



Approved Suppliers: Level-I Fasteners

Please Note:

Seller shall flow down the substance of this provision to all of its suppliers for the procurement of materials contained within this Pervasive Commodity provision in each sub-tier purchase order.

Manufacturers, Distributors, Primes, & etc. must submit a VIR for approval to use a manufacturer who is not on the Pervasive List. Mechanical (post heat-treat final conditions) and chemical test reports are to be submitted with the VIR for NNS Engineering approval.

Level-I Fasteners

Level I Fasteners Requirements

The Seller shall procure Level I Fasteners (MC-I or CM-I) from the supplier sources listed on the approved supplier list. Approval is provided for the supplier source, supplier number and location identified as listed. If a location is not listed, that location is not approved. This applies to Level I material identified by the Buyers purchase orders through the 'Material Group' designation of MC-I (non-nuclear) or CM-I (nuclear). The Seller shall assure that the material procured from sub-tier suppliers is compliant with the material control and traceability requirements of the Buyer's purchase order.

Fasteners include bolts, nuts, studs, bolt-studs, and screws used for joining two parts, components or equipment together and loaded in tension.

Only the manufacturers listed herein may be used to fulfill the Buyers Purchase Orders for fasteners designated as Material Control Level I. In addition to this requirement, the following applies:

1. The manufacturers listed must be the actual manufacturer of the supplied fasteners and they cannot procure or subcontract the manufacture of the fastener to another manufacturer or supplier not on this list.
2. Level I Fasteners provided by an approved Distributor must be manufactured by one of the approved manufacturers for Level I Fasteners. The Distributor is responsible for ensuring that delivered items are in full compliance with the terms and requirements of the Purchase Order. This includes reasonable and sufficient oversight over the sub-tier manufacturing base.
